1	<p>Apologies for Absence</p> <p>Councillors: A Cartie, S Davey, B Erskine, C Humphrey</p>

3	<p>Mayor's Announcements</p> <p>The Mayor opened the meeting by welcoming Les and Margaret Welsh, who have been granted the honour of Freeman of The Town. The scheme was introduced in 2015 and Les and Margaret are the first to be nominated. The Mayor said it was his pleasure to present Les and Margaret with a scroll in recognition of their work over the years with the young, elderly and those with mental health issues.</p>

Alongside this Les and Margaret have run the Empire School of Boxing for over 30 years and have fostered over 35 children. The club are understandably incredibly proud of Savannah Studley who won a bronze medal in the Commonwealth Games.

The Mayor recalled a visit he made to the club and how impressed he was that the children were encouraged to become good people before making them good boxers, teaching them that there are others worse off than themselves by getting the children involved with the foodbanks.

In closing his speech the Mayor said unfortunately, being granted Freeman of Blyth does not mean Les and Margaret can graze their sheep on Crofton Field. He thanked them on behalf of the Council for all of their work.

In response Les said that without the support of Blyth Town Council there would not be the boxing club, as in 2005 the building was for sale and local councillors helped to raise funds and he feels that this was the best investment ever.

He reiterated the comments of the Mayor that the club produce good people first and good boxers second – not everyone can be a boxer but everyone can try and be a good person.

On behalf of himself and Margaret, Les thanked Blyth Town Council for their help and the decision they made to support the club which helped in the way it has evolved over the years.

Since the last Council the Mayor has attended a number of Council events along with other members of the Council, notably the Circus School at the beach, Art in the Park and the sandcastle event, where he almost had to call the coastguard, concerned that Councillor Carr was going to get lost on his paddle board.

Operation Elf has been launched this year. Everyone is familiar with Operation Elf and the Mayor said he would encourage members to support this in any way they can. Information has been posted about drop off points for donations.

Last week saw the official opening of the new South Beach Play area, again attended by a number of Councillors.

	<p>The Mayor was invited to visit the Riverside Centre at Kitty Brewster Industrial Estate to look at the project which the Council helped to fund. This is a fantastic centre and the Mayor would recommend it to anyone who gets the chance to visit.</p> <p>Since the last Council, the country has mourned the death of Queen Elizabeth II. A book of condolence was set up in the foyer of Arms Everytyn House and the Mayor attended a service at St Bede’s Church together with Councillor Potts, Robson and Humphrey. He then travelled to Hexham Abbey for a county service. The Mayor recited the Proclamation of Accession which was videoed for YouTube. Everyone is now looking forward to the Coronation of King Charles III on 6 May 2023.</p> <p>On Monday night the Mayor was at the Phoenix Theatre where the Pride of Place project was showing a series of short films about Blyth.</p> <p>The Mayor and his wife were invited to visit Solingen where they had a wonderful time. As part of the visit there was an official reception and a new charter was signed to celebrate the 60th anniversary of the town twinning – a copy will be displayed in the Council Chamber.</p> <p>A visit was arranged to a High School where they are looking at a new initiative a “Green Classroom”. Solingen has over 140 different nationalities living in the town and have taken in over 3,000 refugees. The Mayor concluded by reading a letter he received from the Mayor of Solingen which emphasises the bond between the two towns.</p>
