RESOLVED unanimously to recommend to Council: The development and implementation of a local policy for voluntary Basic DBS Checks and mandatory in certain cases, including a supporting policy framework outlining process, data protection compliance, and financial implications, and The adoption of the draft children and vulnerable adult safeguarding policy. 7 **Decision Report Insurance Review** The report was discussed at length comparing the risk v benefit. It was proposed and seconded to recommend to council to maintain the self-insurance policy. This went to the vote with four in favour and four against. The Chair exercised his casting vote against. RESOLVED to recommend to Council to move away from selfinsurance and to commit to an insurance policy for external assists under the management and responsibility of the council. 8 **Decision Report Financial Software update** The Clerk gave a verbal update. The Committee noted the progress on the implementation of the new accounting package by Council Officers and the interim Internal Audit report from the Councils Internal Auditor, as outline in the report. 9 **Delegated Actions** There were no delegated actions to consider.
