# 4 Decision Report – motion submitted regarding the 2025/2026 budget

Councillor Nicholson spoke to the motion submitted to increase the Councillors Small Scheme budget from £1,000 to £2,000, viring the additional £16,000 from the Community Funding budget This motion had been seconded by Cllr D Swinhoe.

Members discussed supporting the increase of Councillor Small Schemes budget to £2,000, but not at the detriment of it coming out of the community grants budget.

A counter motion was put forward to keep the Councillors Small Scheme budget as it currently is.

RESOLVED: 5 members in favour, 6 against. Motion not carried.

Cllr BW Elliot entered the meeting.

After further discussion, the original motion went to a vote.

RESOLVED: to maintain the existing overall budget for Community Grants of £173,300. Viring £16,000 from the Community Funding to Councillor Small Schemes. Revised budgets would be: Councillor Small Schemes £32,000

Community Funding £141,300.

## 11 Decision Report - Project Shield

Ian Stevenson from Northumberland County Council gave a presentation to Members on Project Shield, including data provided showing a 37% reduction in anti-social behaviour reported incidents this year compared to 2024. Members were encouraged to ask questions to Northumbria Police and NCC representatives present at the meeting.

It is noted that those who declared an interest as a Northumberland County Councillor could not vote on this item.

As only 5 members present were able to vote on this item, the Council did not meet the quorum of six, and a vote was unable to take place.
